Participants are hereby informed of the following:

1. HALF DAY MORNING TRADING SESSION ON THURSDAY, 30 JANUARY 2014
1.1 Trading on Bursa Malaysia Derivatives will be opened only for the morning session on the eve of Chinese New Year on Thursday, 30 January 2014.

The timing of the trading phases for that day will be as per the table below.

The office of Bursa Malaysia Derivatives, however, will remain open in the afternoon of 30 January 2014.

1.2 Reference to Business Day

Even though the trading hours have been shortened as mentioned under paragraph 1.1, all references to 'Business Day' in Rules of Bursa Derivatives for the purpose of trading on 30 January 2014 will be treated as one (1) business day.

However, where references to 'Business Day' are in relation to non-trading matters, 'Business Day' will be read as one (1) business day ending at the close of business of the Exchange on 30 January 2014.

2. EXCHANGE HOLIDAYS FOR CHINESE NEW YEAR AND FEDERAL TERRITORY DAY

Bursa Malaysia Derivatives will be closed for business from **Friday, 31 January 2014** to **Monday, 3 February 2014**. Bursa Malaysia Derivatives will resume business on **Tuesday, 4 February 2014**.

3. EXPIRATION OF FGLD JAN14 CONTRACT ON WEDNESDAY, 29 JANUARY 2014

The last trading day and expiry of the FGLD Jan14 contract will fall on **Wednesday, 29 January 2014**. The final settlement price for the FGLD Jan14 contract will be calculated using the London AM Fix (USD/troy oz) on **Wednesday, 29 January 2014** converted into RM based on the Bank Negara Malaysia USD/RM 1700 hours middle rate for that day. The FGLD new contract month (May14) will only be listed for trading on Tuesday, 4 February 2014.

4. FINAL SETTLEMENT PRICE FOR FKLI JAN14 ON THURSDAY, 30 JANUARY 2014

Due to the half market day for Bursa Malaysia Securities on Thursday, 30 January 2014, the final settlement price for FKLI Jan14 shall be the average value, rounded to the nearest 0.5 of an index point taken at every 15 seconds intervals from **11:15:30 a.m.** to **12:15:15 p.m.** plus one value after **12:30:00 p.m.** of the FBM KLCI on that day, excepting the 3 highest and 3 lowest values.
