BTS2 FIX Specification on Market Data Handling Market Trade Message (MsgType = X, MDEntryType = 2)



Background

Market trade message for a security can be disseminated due to the following events:

- 1. A new trade (MDUpdateAction = New)
- 2. A trade is amended (MDUpdateAction = Change)

 It is not part of Bursa Malaysia's current practice to change the price and/or quantity of a trade which has already been matched. However, there is a provision to cancel a trade.
- 3. A trade is cancel (MDUpdateAction = Delete)

- 1. Change on Total Number of Trades, Total Trade Volume and Total Trade Value should be reflected accordingly
- 2. The Trade Price is the Last Trade Price for this security

This is a new trade

Every trade has a unique identifier

This is the Last Trade Price

This is the time of the trade execution

At the point of trade cancellation, it is material to observe that:

- 1. Change on Total Number of Trades, Total Trade Volume and Total Trade Value should be reflected accordingly
- 2. The Last Trade Price should reflect the Trade Price with the latest timestamp in FIX Tag 273

This is a cancelled trade

This is the unique identifier of the deleted trade

This is trade price but NOT Last Trade Price

This is the time of the trade execution
