Notes for Sections A (Main Site Model) and B (DRC Site Model)

- i. Minimum network access requirement is one (1) network access point.
- ii. Minimum of two (2) power points is required for each Rack.
- iii. Power point will be of the commando type that comes with a male/female switch.
- iv. Please tick the power Amperage required, either 20 or 32 Amps.
- v. Equipment rack shall not exceed the standard 42U x W600mm X D1000mm.

C. SUPPORT SERVICES

- i. Normal Support Hours is from **9.00am to 5.00pm** during the days that Bursa Malaysia Berhad ("**Bursa Malaysia**") is open for business ("**Business Day**").
- ii. Any support services after the Normal Support Hours during Business Day will be charged at RM150 per man-hour.
- iii. Any support services during Saturday, Sunday or public holidays will be charged at RM300 per man-hour.

D. SUBSCRIPTION PERIOD AND MODE OF PAYMENT

- i. Minimum period of Subscription is one (1) year ("**Initial Term**") from the commencement date.
- ii. The Subscriber shall pay Bursa Malaysia the following as initial payment ("**Initial Payment**") within the timeline stated in the invoice:
 - (a) Quarterly in advance payment which is equivalent to three (3) months of the Subscription Fee; and
 - (b) One Time Installation Fee for the activation of the Subscription services.
- iii. The Initial Payment is **NOT REFUNDABLE**.
- iv. The Subscriber is to pay a security deposit equivalent to three (3) months of Subscription Fee ("**Security Deposit**") within thirty (30) days from the date of invoice issued by Bursa Malaysia. The Security Deposit will be forfeited if the Subscription is terminated during the Initial Term. The Security Deposit shall not be deemed to be treated as payment of the Subscription or any other payment that the Subscriber may be required to pay under the provisions of this Agreement unless prior written consent has been obtained from Bursa Malaysia. The Security Deposit or the balance thereof (if any) shall be refunded to the Subscriber free of any interest less any costs, charges and expenses which Bursa Malaysia may incur within a reasonable time upon termination of the Subscription after the Initial Term provided that the Subscriber is not indebted or otherwise liable to Bursa Malaysia for non-observance of the Subscriber's obligations under this Agreement.
- v. The Subscription Fee will be invoiced in advance on a quarterly basis.
