GUIDELINES FOR APPLICATION FOR REGISTERED PERSON

1. All applicants are requested to carefully study the Rules and Directives of Bursa Malaysia Derivatives Clearing Berhad before submitting their application. The Rules and Directives set out the rights and obligations of all Clearing Participants of Bursa Malaysia Derivatives Clearing.
2. **Registration Procedures for Registered Persons**

The General Clearing Participant of the person who is to be registered as a Registered Person is required to make only one submission through the Securities Commission Malaysia's Electronic Licensing Application ("ELA") System for the purpose of licensing, approval or registration by Securities Commission Malaysia and registration with Bursa Malaysia Derivatives Clearing Berhad.
3. For the purpose of the registration with Bursa Malaysia Derivatives Clearing Berhad, a General Clearing Participant must submit through the ELA System:
 - i. the duly completed Registration Form
 - ii. an undertaking for registration as Registered Person; and
 - iii. If more than 1 Registered Person is appointed by the General Clearing Participant in the areas of overall clearing business, risk management or compliance respectively, a description of the area and responsibility of each Registered Person.
4. By making the submission through the ELA, the General Clearing Participant agrees that although the submission is directed to Securities Commission Malaysia, it forms part of the submission to Bursa Malaysia Derivatives Clearing Berhad. The General Clearing Participant agrees that the relevant information in the submission made through the ELA System (together with Bursa Malaysia Derivatives Clearing Berhad's Information) may be transmitted into Bursa Malaysia Derivatives Clearing Berhad's system for approval, upon Securities Commission Malaysia's approval of the application.
5. The applicant shall submit to Bursa Malaysia Derivatives Clearing Berhad the following (these documents must be typewritten):
 - i. Registration Form
 - ii. Undertaking for Admission as Registered Person; and
 - iv. If more than 1 Registered Person is appointed by the General Clearing Participant in the areas of overall clearing business, risk management or compliance respectively, a description of the area and responsibility of each Registered Person.

8. A General Clearing Participant must retain possession of the original copies of Bursa Malaysia Derivatives Clearing Berhad's Information and must produce such original copies to Bursa Malaysia Derivatives Clearing Berhad at Bursa Malaysia Derivatives Clearing Berhad's request.
9. No Fee is applicable for the registration of the registered person of a General Clearing Participant.
10. **VACANCY OF REGISTERED PERSON (INTERIM)**
The General Clearing Participant must notify Bursa Malaysia Derivatives Clearing Berhad of the identified person under Rule 3.39(2) in the manner determined by Bursa Malaysia Derivatives Clearing Berhad.
