- 5) Duly certified true copy of latest Notice of Situation of Registered Office And Of Office Hours And Particulars Of Change, if relevant;
- 6) Duly certified true copy of latest Particulars of Directors, Managers and Secretaries;
- 7) Duly certified true copy of latest Annual Returns;
- 8) Duly certified true copy of the resolution of the Board of Directors of the applicant authorising the making of this application;
- 9) Duly certified true copy of its previous two (2) financial year's audited statements; if applicant is a new setup, holding company to provide latest two (2) Audited Financial Statements;
- 10) Documentary evidence on the status of the applicant as per categories 3, 4 and 5 in section 1 of the application form;
- 11) Documentary evidence on the requisite experience of the personnel of the applicant as required under the Rule; and
- 12) Any other documents that may be required by Bursa Malaysia Securities Berhad from time to time.
